Proposal Number Two : Bovina Public Library, a Question

Resolved, that pursuant to Section 259 (1)(b) of the NYS Education Law, the Town of Bovina is authorized to levy and collect an annual tax, year after year, separate and apart from the annual Town budget, in the amount of \$40,000, which shall be paid to the Bovina Public Library for the support and maintenance of the library; with this appropriated amount to be the annual appropriation until thereafter modified by a future vote of the electors of the Town of Bovina.
